

Privacy Statement

This privacy statement was last updated on 13.01.2020

Via the website of Digidum B.V. (<https://network.adverce.com>) personal data is collected. Digidum B.V. respects the privacy of all users of its site and also ensure that the personal information which you provide is treated confidentially. Personal data is secured and carefully processed by us. Here we adhere to the requirements of personal data protection act. In this privacy statement, we will explain which personal data we collect and use.

1. Collecting and Processing of Data

By using this website and/or our services, we acquire certain personal data. We only collect, use and save personal data which is given directly by you (for example your name and e-mail address via our contact form or subscribing to the newsletter) or which is clearly stating that they are provided to us for processing. We don't use your personal data for any other purposes unless you have given explicit permission in advance or we are required by law. We also store personal data by cookies. 2. Purposes of the processing of personal data

We process your personal data for the following purposes:

- to grant access to the website <https://network.adverce.com>
- to use the different features of our website;
- to provide our services;
- to contact you, in case you requested us to do so;
- to gain insight into the use of our website;
- to improve and evaluate our website and services;
- to send you our newsletter, if you subscribed.

3. Security

We take appropriate security measures to limit and prevent misuse of and unauthorized access to your personal data. We ensure that only authorized people to have access to your personal data and that access to your personal data is controlled. Digidum also uses firewalls and secure connections (Secure Sockets Layer or SSL), which protects all information between you and the website.

4. E-mail and Newsletter

Registration to the newsletter means that you agree with, on a regular basis, receiving newsletters and e-mails from <https://network.adverce.com>. Each newsletter also contains a link with which you can unsubscribe. You can also contact us via the contact form on the website to request your unsubscription of the newsletter.

5. Retention periods

We will not store your personal data longer than necessary in order to achieve the purposes as named within this privacy statement.

6. Confidentiality and provision to third parties

We will handle your personal data confidential. We will not provide your personal data to any third parties for direct marketing purposes of these parties. Moreover, we will not provide your personal data to any other party, unless this is necessary for the execution of an agreement or if we are legally obliged or allowed to do so

7. Third Party Websites

This statement does not apply to third party websites which are connected with this website. We cannot guarantee that third parties handle your personal information in a safe manner. We would strongly recommend you to read the privacy statement of the third party websites before filling your personal data there.

8. Rights of the data subject

In case you have provided us with your personal data, you can send us a request to see, adjust, delete or in some cases displace or restrict this personal data. 9. National supervisory
